



## REQUEST FOR CHILD'S LEAVE OF ABSENCE DURING TERM TIME

## **NOTES TO PARENTS/CARERS**

The 2013 amendments to the 2006 regulations make it clear that Head Teachers may not grant any leave of absence during term time unleare exceptional circumstances, and that Head Teachers should determine the number of school days a child can be away from school if the is granted.

The law does not grant parents an automatic right to take their child out of school for holidays during term time. You must apply for permissin advance.

When deciding whether to allow term time leave the school will consider the reason for the absence and whether it is deemed to be an exce circumstance.

Generally, the DfE does not consider a need or desire for a holiday or other absence for the purpose of leisure and recreation to be an excecircumstance.

If the request for leave of absence is refused and the absence is recorded as unauthorised, the Head Teacher may refer the matter to the L Authority requesting a Penalty Notice be issued against you.

A Penalty Notice is £80 if paid within 21 days of receipt, rising to £160 if the notice is paid after 21 days but within 28 days. If the penalty is paid in full by the end of the 28 days period, the Local Authority may prosecute for the offence to which the notice applies.

Any second penalty notice issued to the same parent for the same child in a rolling 3-year period, the charge will be at a higher rate of £160 no option for this second offence to be discharged at the lower amount of £80.

A national limit of 2 penalty notices can be issued to a parent for the same child within a rolling 3-year period so at the 3rd (or subsequent) offence(s) the Local Authority will investigate legal interventions such as prosecution.
